Sub : Request for submission of drawing for visualization & designing of Maharashtra Pavilion in India International Trade Fair 2026, Pragati Maidan, New Delhi.

Every year India Trade Promotion Organization (ITPO), New Delhi is organizing India International Trade Fair during the period 14th to 27th November at Pragati Maidan, New Delhi. MSSIDC on behalf of Government of Maharashtra organizing Maharashtra Pavilion in said fair. This year theme of India International Trade Fair is Development & Heritage

(विकास और विरासत)

This year Maharashtra desired to showcase the "Maharashtra's Saint Tradition, The Twelve Balutedar System & The History of Chhatrapati Shivaji Maharaj" (महाराष्ट्राची संत परंपरा, बारा बलुतेदार पद्धती आणि छत्रपती शिवाजी महाराजांचा इतिहास) on the total area of the Maharashtra Pavilion approximate 1100 sq.meter. Also 3 x 2 sq.meter size appx 65 gala shall also be planned in the design.

In this regard, it is requested as follows :-

- (1) The agency is requested to make the design as per "Maharashtra's Saint Tradition, The Twelve Balutedar System & The History of Chhatrapati Shivaji Maharaj" (महाराष्ट्राची संत परंपरा, बारा बलुतेदार पद्धती आणि छत्रपती शिवाजी महाराजांचा इतिहास). The design shall include 3 x 2 sq.meter size appx 65 gala for display and sale of items. One gala should be designed for live demonstration paithani weaving on loom. (Loom will be arranged by MSSIDC).
- (2) The agency is requested to submit the design for Maharashtra Pavilion in hard copy (2D or 3D). The agency may provide options of designs. There is no limit for providing options of designs.
- (3) The agency is required to give the presentation of the design prepared before the MSSIDC.
- (4) The agency whose design is selected by the High Power Committee, Govt. of Maharashtra will be required to prepare detailed design, working drawing, detail estimate as per PWD DSR wherever applicable, 3D model. Also, to carry out the supervision of actual work executed at site and certify the bills submitted by the contractor.
- (5) The agency shall quote their professional fees/charges for the work mentioned at sr.no.3 alongwith drawing and estimate.
- (6) The professional fees/charges shall be excluding GST.
- (7) The agency whose design is selected by the High Power Committee, Govt. of Maharashtra will be paid honorarium of Rs.50,000/- including GST.
- (8) The design and estimate shall be submitted by 27.07.2026 positively to this office.
